Certification periods are ten years and maintenance is dependent on the ability of the diplomate to display competency in four areas of assessment: evidence of professional standing, evidence of commitment to lifelong-learning and periodic self-assessment, evidence of cognitive expertise, and evaluation of performance in practice.

The American Board of Venous & Lymphatic Medicine was established to:

1. Improve the standards of medical practitioners and the quality of patient care related to the treatment of venous disorders and all aspects of venous disease;
2. Serve the public and the medical profession by establishing initial and continuing qualifications for certification and maintenance of certification as physician specialists in the practice of venous and lymphatic medicine;
3. Examine physician candidates for certification and maintenance of certification in the practice of venous and lymphatic medicine;
4. Establish educational standards for teaching and training programs in venous and lymphatic medicine;
5. Award certifications in venous and lymphatic medicine to candidates who meet the established requirements;
and
6. Maintain a registry of individuals who hold certificates issued by the Board.
